5. Online will be mentioned in degree?

6. Will the practicality of online & offline degree be same ?
Ans. Both the degrees credibility will be same as we are perfectly UGC approved. As per the UGC guidelines, Online degree will be considered as equivalent to the regular.
7. What all documents required for UG / PG programme ?
Ans. Adhaar Card ,Passport size photo,10th marksheet ,12th marksheet: for UG, in-addition Graduation Marksheet: for PG all these documents required for admission in programme.
For International Learner: Along with these documents, Passport & AIU equivalency certificate are required.
8. Original documents required or internet photo copy will be accepted ?
Ans. It is mandatory to provide original documents.
NB: Scanned of black & white printed copy is not accepted.

10. For admission calling from from third party or direct from KIIT Deemed to be University ?
Ans. We calls directly from the University to all, whose queries are found in Chat Box.
11. Does KIIT Deemed to be University Online Learning Platform offer scholarships or financial aid for students?

16. What is the exam pattern?

Ans. The examination includes two assessment: Internal assessment and External assessment; Internal assessment weightage 30 marks in which MCQs will be available and External assessment weightage 70 marks in which MCQ & Descriptive questions will be available.

17. When the exams will be conducted?

Ans. For January session students exams will be held in June and for the July session will be held in December.

18. Can we connect to faculty ?

Ans. You can connect to the faculty through chat during online classes, and after that if you will have any doubt then you have to mail to support for the doubt session where you can connect to the faculty.

19. What will be the the timing for classes ?

Ans. The schedule of classes will be given in the academic calender which will be available in the student portal which students has to be followed. Also, Just you have to login to the Learning Management System (LMS) portal and the schedule of classes will be available there.

20. Will attending these programme add to my attendance requirement for the programme?

Ans. As per the University Grants Commission (UGC) regulations, a student needs to complete 75% of the learning requirement to be eligible to appear for exams of an online degree programme that includes: Reading through the e-content, Completing assignments and Live classes & Recording classes.

21. What is the refund policy?

Ans. If a student want to refund then student has to email us with reason then Counsellor will forward the same to the seniors once it will be approved by the seniors then counsellor will speak to the student and ask student to fill the withdrawal form sent it back to us with a fee receipt & Bank passbook copies of account details.
